## Lip Sync Battle Rules & Regulations

1. Registration is open to the first 10 teams or individuals that submit the completed form and music. Forms can be printed from the website (babyfoodfestival.com) or picked up at the Chamber office. All completed forms and music must be turned in at the Chamber office by July 16<sup>th</sup> at 4:30pm.
2. Teams can range in size from 1 to 8 people. All team members names must be included on the registration form. Only the individuals listed on the registration form will be allowed to perform.
3. Individuals can only compete in one performance.
4. Teams may use props - these props must be included on the registration form to be approved by the NBFF Committee. Props not included on registration form cannot be used in the performance. Fog machines, bubble machines, fire, water, and glitter are prohibited.
5. Music must be submitted with completed registration form by July 16<sup>th</sup> at 4:30pm to be approved by the NBFF Committee. Songs must be the **edited version**. Songs/performances containing curse words, vulgarity, or inappropriate innuendoes will **NOT** be permitted . Please remember this is a **“family friendly event”**. Failure to submit music may result in the team’s registration being cancelled. **Teams will be notified by July 17<sup>th</sup> by 4:30pm (at the number listed on the registration) whether they have been approved to participate.**
6. Maximum time limit for your performance or song will be limited to no more than 10 minutes in length, including setup and take down. Please understand that we are under a time limit. It is only fair to all that we use the same time limit.
7. The NBFF Committee reserves the right to cancel a registration if the Committee feels the act is inappropriate or offensive to others. If an offensive act is performed, the NBFF Committee reserves the right to terminate the performance and the act will be disqualified.

The competition will be judged in these categories:

- ✓ **Lip Sync Abilities:** How well the performer(s) lip sync the lyrics of the song.
- ✓ **Creativity:** How original and creative the performance is, as opposed to just standing on stage and lip syncing a song, props, choreography, costumes and/or other ideas should be used and often impresses the judges and generates crowd response. Be creative!
- ✓ **Stage Presence & Choreography:** Don’t just stand there! Engage the audience, dance, smile, make eye contact with the judges...you’re a STAR ---have fun!

**Each category will be worth 15 points each. In case of a tie, the act with the highest ‘Lip Sync Abilities’ score will win. The Judges decisions will be final!!**

**Awards will be presented to the winners.**
